Whereas, Successor Declarant filed an Approval and Ratification of the Plat of Boulder Canyon Replat A dated September 10, 2014 under Document No. 20140058890, Real Property Records of El Paso County, Texas; and

Whereas, Successor Declarant has filed a Replat of the Subdivision known as Boulder Canyon Replat B; and

Whereas, Successor Declarant filed a Second Amendment to the Declaration of Covenants, Conditions and Restrictions for Boulder Canyon, Replat B, dated December 31, 2014 under Document No. 20150003055 in the Real Property Records of El Paso County, Texas; and

Whereas, Successor Declarant filed a Third Amendment to the Declaration of Covenants, Conditions and Restrictions for Boulder Canyon, Replat B, dated January 22, 2015 in the Real Property Records of El Paso County, Texas under Document No. 20150005040; and
