## CORPORATE NAME

1. The name of the corporation is MEDICAL PLAZA OWNERS ASSOCIATION, INC.

# LEGAL STATUS

2. The Corporation is a nonprofit corporation organized pursuant to the Texas Nonprofit Corporation Act.

### DURATION

3. The period of duration of the corporation is perpetual.

## **PURPOSES**

- 4. The purposes for which the corporation is formed are:
- (a) Specifically and primarily to provide an organization consisting of the owners of the condominium project in order to provide for the management, maintenance, preservation, and architectural control of the condominium project located in El Paso, State of Texas and more particularly described in the declaration recorded in the Office of the County Clerk of El Paso County, State of Texas, on January 21, 1992 in the Condominium Records, Book No. 2391, Pages 924-951.
- (b) Generally:
  - (i) To promote the health, safety, and welfare of the Owners of the Condominium Project.
  - (ii) To exercise all of the powers and privileges and to perform all of the duties and obligations of the Counsel as set forth in the Declaration and Bylaws.
  - (iii) To fix, levy, collect, and enforce payment of any charges or assessments as set forth in the Declaration and to pay all expenses in connection with such charges or assessments, all office expenses and all other expenses incidental to the conduct of the business of the corporation, including all licenses, taxes, or governmental charges levied or imposed against the property of the corporation.

- (iv) To acquire (by gift, purchase, or otherwise), own, hold, improve, build on, operate maintain, convey, sell, lease, transfer, dedicate for public use, or otherwise dispose of real or personal property in connection with the affairs of the corporation.
- (v) To borrow money, mortgage, pledge, deed in trust, or hypothecate any or all of the corporation's real or personal property as security for money borrowed or debts incurred.
- (vi) To have and to exercise any and all powers, rights and privileges that a corporation organized under the Texas Non-Profit Corporation Act by law may now or at a later time have or exercise.
- (vii) To act in the capacity of principal, agent, joint venturer, partner, or otherwise.
- (c) Notwithstanding any of the above statements of purposes, the corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purposes of the corporation.

## INITIAL REGISTERED OFFICE AND AGENT
