If a different color/texture/design is desired, a variance request must be submitted to the ARC for review and approval.

The following fence/gate colors or a color matched equivalent have been approved and must be used when repainting fences:

Green Color selected is Sherwin Williams SW7742 Agate Green Tan color selected is Sherwin Williams SW9103 Farro

2. Exhibit "A" to the Declaration of Covenants, Conditions and Restrictions for Block 1, Sunstone Addition Site Work and Building Design Requirements is hereby amended by addition of the following to Attachment "B":

If a property owner wishes to repaint or re-roof their house, paints or roofing material that match the existing color/texture/design shall be used. If a different color/texture/design is desired, a variance request must be submitted to the ARC for review and approval.

The following fence/gate colors or color matched equivalents are the only ones approved for painting of the fences and/or gates:

Green Color selected is Sherwin Williams SW7742 Agate Green

Tan color selected is Sherwin Williams SW9103 Farro

Sherwin Willimas Sunstone Green

Except as amended by this Fifth Amendment to Declaration Of Covenants Conditions and Restrictions of Sunstone Addition, Replat "A", the Declaration Of Covenants Conditions and Restrictions of Sunstone Addition, Replat "A" shall continue in full force and effect under its original terms.

Terms not otherwise defined herein shall have the same meaning as in the Declaration Of Covenants Conditions and Restrictions of Sunstone Addition, Replat "A"
