WHEREAS, the Declarant desires to amend Article 4.4(a) of the Declaration.

NOW, THEREFORE, in consideration of the mutual covenants herein contained and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged and confessed, Declarant hereby amends the Declaration as follows, towit:

- 1. <u>Capitalized Terms.</u> The capitalized terms as used herein have the same meaning assigned to such terms in the Declaration, unless the text of this Second Amendment states otherwise.
- 2. <u>Classes of Voting Membership</u>. Section 4.4(a) of the Declaration is hereby amended so as to read as follows:
 - (a) "When Declarant or a Related Party to it, owns, either separately or jointly, a total of not more than one (1) Lot, which may be a Personal Lot," or
- 3. <u>Ratification</u>. Except as modified hereby, the terms and conditions of the Declaration are hereby ratified and confirmed by the Declarant.
