ARTICLE ONE

The name of the corporation is CORINTHIAN TOWNHOMES ASSOCIATION, INC.

ARTICLE TWO

The corporation is a nonprofit corporation, no part of the income of which is distributable to any members, directors, trustees or officers and no part of the net earnings of which shall inure to the benefit of any private individual.

ARTICLE THREE

The period of its duration is perpetual.

ARTICLE FOUR

The purposes for which the corporation is organized are:

- 1. To provide a means of administering, preserving and maintaining a condominium project to be known as Corinthian Townhomes, all in accordance with the terms and provisions of the Condominium Act of the State of Texas, Article 1301a Vernon's Annotated Texas Statutes, and the Condominium Declaration for the project filed or to be filed pursuant to the Act in the Condominium Records of El Paso County, Texas;
- 2. Subject to part 4 of the Texas Niscellaneous Laws Act, to exercise all powers of a nonprofit corporation as set forth in the Texas Nonprofit Corporation Act and to do all other things necessary and proper to accomplish the purposes set out herein and to administer and enforce the
